The Lyon County Fiscal Court met in regular session on Thursday, August 13, 2015 with the following members present: Judge Wade White, Magistrates Bobby Cummins, Danny Walker and Steve Cruce and County Attorney Lee Wilson.

OPEN BIDS

The fiscal court received two bids for the illegal dumpsites in the county.
