The Lyon County Fiscal Court met in regular session on Thursday March 10, 2016 with the following members present: Judge WadeWhite, Magistrates Steve Cruce, Danny Walker and Bobby Cummins and County Attorney Lee Wilson.

The invocation was given by Aaron Brown and the court led the pledge to the flag.

Visitors comments:

Don McKinney expressed concerns regarding the accessibility to the bathrooms for the handicap from the softball field; the pavilion that was built by Don Wallace not having accessibility; and the new proposed concession stand building.

On motion made by Mag. Walker and seconded by Mag. Cummins the court ask Richard Mitchell of Waycon Construction to draft the accessibility walkway from the softball field to the bathrooms. The vote was unanimous.

James Lester Dorroh petitioned the court to take in 550 feet of White-Dorroh Road into the county road system. This would be an extension of the footage of White Dorroh Road that is already in the system. Mr. Dorroh needs a waterline laid down the additional 550 feet and the Water District requires the additional footage be a county road before they can lay the line. Otherwise it would be laid on private property at a cost to the landowner.

Mr. Dorroh will get copies of the abutting landowners property deeds and give them to the County Attorney.

On motion made by Mag. Walker and seconded by Mag. Cruce the county will send road viewers to the additional footage of White Dorroh Road and will report to the court their findings. The vote was unanimous.
