

# LYON COUNTY FISCAL COURT REGULAR MEETING OCTOBER 8, 2015

The Lyon County Fiscal Court met in regular session on Thursday October 8, 2015 with the following members present: Judge Wade White, Magistrates Bobby Cummins, Danny Walker and Steve Cruce and County Attorney Lee Wilson.

Carl Nelson gave the invocation and the court led the pledge to the flag.

The court heard a brief discussion from Mr. Jerry Padgett. He told the court he now had internet service but not with FastNet. He said he called DishNet and had internet service within 23 hrs.

Ms. Yasman Ausenbaugh spoke to the court about Sanctuary House. It is a safe house for women or men who find themselves in an unsafe environment. The house is located in Hopkins County.


The claims were reviewed and ordered paid.
