**ORDINANCE AUTHORIZING AND DIRECTING ADDITIONAL COURT  
COSTS FOR THE PURPOSE OF COSTS RELATED TO COURT FACILITIES**

WHEREAS, the budget for the Commonwealth of Kentucky was enacted by the General Assembly during the year 2000 session; and

WHEREAS, said budget for the Commonwealth of Kentucky was signed by the Governor of the Commonwealth of Kentucky in April 2000; and

WHEREAS, by the terms of said budget it will take effect on July 1, 2000 and thereafter:  
and

WHEREAS, said budget of the Commonwealth of Kentucky allows county fiscal courts to impose by ordinance additional costs relating to district courts, circuit courts and the sheriff's office.

NOW THEREFORE, IT IS HEREBY ORDAINED BY THE FISCAL COURT OF LYON COUNTY, COMMONWEALTH OF KENTUCKY, pursuant to FB 2000 - 2002 Budget Modification Report as follows:

In Circuit Court:

1. In civil cases, a fee of \$25.00 is added to filing fees.
2. In criminal cases, a cost of \$25.00 is added to the court costs that the defendant is required to pay.
3. In civil cases that are appealed from Circuit Court to the Court of Appeals, a fee of \$25.00 is added to the filing fees.

In District Court:

1. In all traffic offenses, a fee of \$10.00 is be added to the court costs for each traffic offense.
2. In probate cases, a fee of \$10.00 is added to each filing fee.
3. In misdemeanor cases, a cost of \$20.00 is added to the court costs.
4. In small claims, a fee \$10.00 is added to all filing fees.
5. In civil cases, a fee of \$10.00 is added to the filing fees.
6. In felony cases, a cost of 25.00 is added to the court costs.
7. On all appeals from District Court to Circuit Court, a fee of \$25.00 is added to the filing fees.

Subpoenas:

In addition to the fees normally charged for the service of a subpoena, the person requesting service is to be charged a fee of \$10.00.


Civil Summons:

In addition to the fees normally charged for the service of a civil summons, the person requesting service is to be charged a fee of \$10.00.


This Ordinance shall be in full force and effect on the 15 day of July, 2000.


Hereafter, the Clerk of Lyon Circuit Court and the Lyon County Sheriff shall no later than monthly remit to the Lyon County Treasurer all the increased fees set forth herein. Said fees shall be expended for the purpose of paying expenses for the local jail, courthouse, bonds relating to same and the administration thereof.
