ORDINANCE AUTHORIZING AND DIRECTING ADDITIONAL COURT
COSTS FOR THE PURPOSE OF COSTS RELATED TO COURT FACILITIES

WHEREAS, Ordinance No. 220.10 duly enacted by the Lyon Fiscal Court effective July 6, 2000, and as amended, May 23, 2001, was authorized by FB 2000 - 2002 Budget Modification Report, and

WHEREAS, such authorization is due to expire June 30, 2002, and

WHEREAS, the County of Lyon is still desirous of collecting additional costs relating to district courts, circuit courts and the sheriff's office,

NOW THEREFORE, IT IS HEREBY ORDAINED by the Fiscal Court of Lyon County, Commonwealth of Kentucky, pursuant to KRS 23A.220, KRS 24A.185, and KRS 64.091, as follows:

In Circuit Court:

1. In civil cases, a fee of \$25.00 is added to filing fees.
2. In criminal cases, a cost of \$25.00 is added to the court costs that the defendant is required to pay.
3. In civil cases that are appealed from Circuit Court to the Court of Appeals, a fee of \$25.00 is added to the filing fees.

In District Court:

1. In all traffic offenses, a fee of \$10.00 is be added to the court costs for each traffic offense.
2. In probate cases, a fee of \$10.00 is added to each filing fee.
3. In misdemeanor cases, a cost of \$20.00 is added to the court costs.

4. In small claims, a fee \$10.00 is added to all filing fees.

5. In civil cases, a fee of \$10.00 is added to the filing fees.

Subpoenas:


In addition to the fees normally charged for the service of a subpoena, the person requesting service is to be charged a fee of \$10.00.

Civil Summons:

In addition to the fees normally charged for the service of a civil summons, the person requesting service is to be charged a fee of \$10.00.


This Ordinance shall be in full force and effect on the 1st day of July, 2002. Hereafter, the Clerk of Lyon Circuit Court shall no later than monthly remit to the Department of Finance in Frankfort, Kentucky, all monies received under this ordinance. The Lyon County Sheriff shall no later than monthly remit to the Lyon County Treasurer all increased fees set forth herein and received hereunder. Said fees shall be expended for the purpose of paying expenses for the courthouse, bonds relating to same and the administration thereof.
