1991 OFFICIALLY NAMED ALL ROADS IN LYON COUNTY,
KY, AND

WHEREAS, CERTAIN DELETIONS, MODIFICATIONS, AND
ADDITIONS ARE NECESSARY IN ORDER TO FULFILL THE
PURPOSES OF SAID ORDINANCE,

NOW THEREFORE, BE IT ORDAINED, BY THE FISCAL COURT OF LYON COUNTY,

EXHIBIT CONSISTING OF 1 PAGE BE, AND THEY HEREBY ARE, OFFICIALLY ADOPTED
INTO, (OR DELETED THEREFROM) AND DESIGNATED AS THE OFFICIAL NAMES OF
ALL CURRENTLY IDENTIFIED ROADS IN LYON COUNTY IN ADDITION TO THOSE
DESIGNATED IN THE AFOREMENTIONED ORDINANCE PASSED OCTOBER 10, 1991 AND
IN THE AMENDMENT THERETO DATED APRIL 9, 1992.
