ORDINANCE NO. 02-2019

AN ORDINANCE AMENDING THE COUNTY'S ALCOHOL ORDINANCE, LYON COUNTY
FISCAL COURT ORDINANCE 410.1

WHEREAS, Lyon County Ordinance 410.1 was duly enacted by the Lyon County Fiscal Court in 2013 to permit the sale of alcoholic beverages in Lyon County;

WHEREAS, Article Five of Lyon County Kentucky Ordinance 410.1, Section 5.01 Hours of Sale provides the hours during which alcoholic beverages may be sold in Lyon County, Kentucky;

WHEREAS, the Lyon County Fiscal Court desires to amend the permitted hours during which alcoholic beverages may be sold in Lyon County, Kentucky;

NOW THEREFORE BE IT ORDAINED BY THE LYON COUNTY FISCAL COURT:

Lyon County Ordinance 410.1, Section 5.01 Hours of Sale, subsection A. is hereby amended as follows:

5.01 HOURS OF SALE

- A. Premises for which there has been granted a license for the retail sales of alcoholic beverages shall be permitted to sell or offer for sale alcoholic beverages only between the hours of 6:00 a.m. and 12:00 a.m. each day of the week, ~~except Sunday. It shall be unlawful to sell or offer for sale any alcoholic beverages during the twenty-four (24) hours of each Sunday.~~

This Ordinance shall take effect and be in full force when passed, published and recorded.
