COUNTY ROAD SYSTEM APPROACH PERMIT AMENDMENT**

ORDINANCE NO. 04-2018

AN ORDINANCE AMENDING LYON COUNTY ORDINANCE 620.1 REGARDING APPROACH
TILES ON COUNTY RIGHTS OF WAY

WHEREAS, Lyon County Ordinance 620.1 was duly enacted by the Lyon County Fiscal Court in 1979;

WHEREAS, the Lyon County Fiscal Court desires to amend the requirements for approaches connecting to the Lyon County, Kentucky road system maintained by Lyon County;

NOW THEREFORE BE IT ORDAINED BY THE LYON COUNTY FISCAL COURT:

Lyon County Ordinance 620.1 is hereby amended as follows:

Section One. No approach tile shall be installed on the county rights-of-way without first making application for a permit and obtaining such permit from the Lyon County Judge Executive.

Section Two. ~~Prior to the issuing any permit the Lyon County Judge/Executive shall consult with the appropriate magistrate of the magisterial district in which the applicant resides or in which he desires to install said approach tile. In no event shall a permit be issued for the installation of an approach tile with less than a 15 inch diameter and less than 20 feet in length.~~ **The Lyon County Judge/Executive, or his appointed designee, shall issue preliminary and final approach permits for any approach on Lyon County rights-of-way.**

Section Three. ~~The violation of this ordinance shall constitute a misdemeanor and upon conviction the violator shall be subject of a fine of not less than fifty (50) dollars and not more than three hundred (300) dollars.~~ **Any person found to be in violation of this Ordinance shall be guilty of a Class A Misdemeanor.** In addition, **the county may remove any approach installed or maintained without a final approach permitted as set forth herein and the** violator shall be liable to the county for any damage caused by the improper and illegal installation and shall further be liable to the county for the costs of removing same.

This Ordinance shall take effect and be in full force when passed, published and recorded.


