BE IT ORDAINED by the Fiscal Court of the County of Lyon, Commonwealth of Kentucky:

WHEREAS, an ordinance passed December 1, 1981 established a county system of maintained roads in Lyon County, and

WHEREAS, certain public roads were designated in said ordinance which are to be entitled to public maintenance, and

WHEREAS, the Lyon Fiscal Court is desirous of designating roads in South Park Subdivision, more specifically, Jack's Way and Hugh Drive as same are depicted on a plat of said subdivision of record in Plat Cabinet 1, Slide 191 as amended by Slide 3, as being entitled to receive public maintenance,

NOW THEREFORE, BE IT ORDAINED by the Fiscal Court of Lyon County, Kentucky, all roads as aforementioned in South Park Subdivision be, and hereby are, officially adopted into and designated as a part of the county system of maintained roads. This amendment is in addition to those designated in the aforementioned ordinance passed December 1, 1981 and any amendments thereto.
