911 INTERLOCAL AGREEMENT  
ORDINANCE NO. 16-02**

AN ORDINANCE ADOPTING AN INTERLOCAL AGREEMENT BETWEEN LYON COUNTY AND  
KENTUCKY STATE POLICE FOR 911 SERVICES

WHEREAS, the Lyon County Fiscal Court recognizes the importance of 911 services to Lyon County;

WHEREAS, the Lyon County Fiscal Court previously adopted Lyon County Ordinance 300.6 relating to the imposition and administration of 911 services in Lyon County and

WHEREAS, Kentucky State Police has presented Lyon County an Interlocal Cooperation Agreement whereby the Kentucky State Police will continue to provide 911 and other services to Lyon County;

**NOW THEREFORE BE IT ORDAINED BY THE LYON COUNTY FISCAL COURT:**

**SECTION I – ADOPTION AND EXECUTION**

The Lyon County Fiscal Court hereby adopts the terms and conditions contained within the Interlocal Cooperation Agreement, attached hereto, labeled “Exhibit A” and incorporated herein by reference. The Lyon County Fiscal Court further authorizes the Lyon County Judge Executive to execute any documents necessary to effect the adoption of said agreement.

**SECTION II – SURCHARGE**

A surcharge, as defined in the attached Interlocal Agreement and as calculated and conditioned in Lyon County Fiscal Ordinance 300.6, is hereby authorized.

**SECTION III – LYON COUNTY ORDINANCE 300.6**

All other terms and conditions contained in Lyon County Fiscal Ordinance 300.6 shall continue to be in full force and effect.

This Ordinance shall take effect and be in full force when passed, published and recorded.






